Charter Renewal extended through 2027. New Laws: SB765 increases CalSTRS post retirement compensation earning limit from 50% to 70%. SB710 requires safety plans for grades 7 and up to include protocol for opioid overdose. SB291 prohibits school staff members from restricting a pupil's recess unless there is an immediate threat to the physical safety of the pupil or physical safety of one or more of the pupil's peers. Charter Schools are not funded the same as traditional public schools (ex: transportation, facilities, ADA hold harmless) especially when it comes to mandates. Mandate Block Grant funded at ½ the rate. Kindness Week is February 5th-9th. Thank you Sperbeck's Nursery for donating 500 rocks for the students to paint during Kindness Week. Red Across America Week is February 26th- March 1st. Professional Development: Math Frameworks, TK Walkthrus and Unit development, Make & Take for TK, Staff PD day is March 8th Unit and Assessment Design, Toileting Practice for TK.
