- 1. Leadership: Mrs. Kassi Kee
- 2. Enrollment Update: Mrs. Lindsay Rhoades- At the end of February enrollment was 472 with ADA 96.65%. We added 4 new students for Trimester 3, which will reflect on next month's attendance/enrollment update. Open enrollment for the 2023/24 school year closed on Tuesday, February 28th at 4PM to be considered for the lottery on Thursday, March 9th at 8:30AM. We received 210 applications for TK-8th grade.
- 3. Financial Update: Mrs. Becky Whitaker- Amazon Smile will discontinue effective 2/20/23. Amazon will make one final payment equivalent to 3 months of prior payments. Second Interim major changes- Fund balance decreased by around \$366,000 due to 3 major budget adjustments: \$186,000 was one-time adjustments for Distinguished School recognition, staff and student incentives and travel expenses for the ceremony; \$168,000 was on-going due to 4% salary increase; \$12,000 was SELPA model funding adjustments that may change again prior to the close of the year. Multi-Year projections show large COLA for 2023/24 = 8.13%; Spending down committed funds for facility expansion by \$1,000,000 per year through 2025/26. These will hit multi-year projections as services (lease payments). Changes that are still pending in 2022/23- ADA may come in over budget (potential \$245, 000 increase), Arts, Music, Instructional Materials Block Grant may be reduced by ⅓ with governor's budget proposal (potential \$97,000 decrease). These funds are not currently in the budget to be spent. 2023/24 Budget Preparation has begun and will be presented in June along with the 2022/23 estimated actuals budget. Form 700 due to CBO by April 1st annually. Becky sent out the prior year and current year electronic format by email. Copier Lease discussion- lease ends 11/28/2023, CBO recommends UBEO- purchase, change color copies for middle school and monitor color/ black and white coping levels for all staff. Utilize Universal Pre-K grant for 1 machine and Learning Recovery Block Grant for the remaining machines. Budget and pay maintenance contract out of general fund.
