- 1. Enrollment: Mrs. Lindsay Rhoades- 467 students; will fill openings at Trimester 2
- 2. Financial Report: Mrs. Becky Whitaker- First Fundraiser in a couple of years and it was Stephen's Farmhouse, 156 students participated this year and we sold over 3,000 jars of jelly, which is a total of \$20,000 and the school gets over \$7,000, it was a very successful fundraiser that will help pay for field trips. Tiger Care has record enrollment of 120 students, we also have a flier up front that let's families know that if they qualify for free/reduced lunches they can get a reduction in Tiger Care fees. We hired a few more Tiger Care staff which is covered by the tuition Tiger Care is bringing in. Food Service is doing great with Yuba City Unified, they brought in a fresh fruit/veggie bar which the students are really enjoying. Food Service quarterly report next month.

- 4. Data & Assessment: Mr. Obie Leff- Student Performance Index (SPI)- provides an overview of our Data and Assessment initiatives supporting students in achieving the TRCS vision; it's a 12month timeline of data presentations to the board of directors. CAASP scores are still not publicly available as determined by the state but I would like to share with our school community that TRCS has received our scores internally and we have looked at each and every students score and the scores have been shared with the teachers and they are available in the student/parent portal. Solar, special thank you to the Erik Karlshoej Foundation for improving our campus with solar. TRCS is exploring the idea of a Green Ribbon School application.
- 5. Safety Update: Mrs. Christina Jolly- September is Suicide Prevention Awareness Month, Sara and Kelsey went into the middle school classrooms today and showed a video this is the second leading cause of youth in America and if this is something you're experiencing or know someone that is going through make sure you reach out to a trusted adult. Our SEL lessons are in full swing in our middle school advocacy classes. Shout out to our counseling team. We had our first volleyball game yesterday outside. A shout out to Mr. Sierra, Ms. Correa and Mrs. Fresquez for coaching and make it happen for our students. Attendance numbers since the beginning of school we've had 40 students out with COVID or have been exposed to COVID, some students have returned and some have been added to the list. Today, Sept 8th, we had 43 absences; 25 of those were absent and 18 were on quarantine because they were either exposed in the community or at school and not providing a test. What it looks like when a student is on campus and does pose an exposure to

classmates, it takes anywhere from 2-4 hours to COVID trace that particular incident between the county and our school resources and then on top of that we do offer testing which we are one of few schools in our community that offer testing on campus to keep our students in school which is our top priority.
